

The Numbers Tell Us About Pension Health Excellence

Pension Fund statistics are not easy to explain, but please allow me this attempt.

Your Pension Funds (for police and firefighters) are ranked second and third among the billion dollar+ systems in Texas as you will see in the chart below.

Of all the places you could work, our systems have the fewest years needed to "pay off" future benefits owed to our members. That is called the "Amortization Period," and it's like a home mortgage – the fewer years the better.

Please understand that it is just a measure – most pension funds never get "paid off" because they



are structured to run for as long as we have firefighters and police for the City of El Paso. We are already well below the level of

> 30 years which the state monitoring agency called the Texas Pension Review Board wants us to be at.

This should make you very confident about your future benefits.


These innovations have enhanced efficiency, ensuring that EPFPPF continues to thrive while navigating the complexities of managing billions of dollars.

Ashley replaces former CFO Lena Ellis who retired at the end of 2024 with 10 years of service to EPFPPF.

The hiring concluded a 5-month nationwide search for the best applicants to fill the specialized needs of governmental and fund investments accounting.

Ashley Tierney is a governmental finance professional with over 10years of experience in both the federal and municipal level sectors.

She also has 3+years experience in governmental auditing with focuses on local municipalities, school districts and fraud related audits/investigations.

Ashley obtained her Master of Accountancy with a focus in audit from the University of Texas at El Paso.

She is a Certified Public Accountant, a Certified Fraud Examiner as well as a Certified Governmental Financial Manager. She is an active member of the Association of Fraud Examiners, Association of Governmental Accountants, Institute of Internal Auditors, and the American Institute of Certified Public Accountants.

"The Trustees are confident that Ashley Tierney will pick up where Lena left off and will assist us immediately in the selection of new accounting software needed to keep up with our growing needs," said Sean Shelton, Chairman of the


EPFPPF Board.

My primary focus is on maintaining the financial health and sustainability of the fund. With some of my experience in system implementations, I can also assist the fund with any process streamlining to help ensure long term efficiency as well.

Can you share an example of a successful financial strategy or initiative you implemented in previous roles?

In my experience, one of the hardest obstacles an entity can face is ensuring continuity of operations during employee loss/turnover. Often the staff member takes with them years of historical knowledge leaving the entity impaired in their absence.

For this reason, in my previous roles I've ensured that implementing internal controls that lend to operational continuity, in case of historical knowledge loss, is always a priority.

While it's a large undertaking that involves constant updating, ultimately the entity and staff alike greatly appreciate a well-lit road to navigate difficult transitions.

Trustee Matters: New Beginnings

The Board of Trustees of the El Paso Firemen and Policemen's Pension Fund welcomed two new members to its ranks, celebrated the career of a retiring member, and reembraced two returning member.

Returning Chair Shelton as Police Active Trustee

The Active Police Trustee position currently held by Sean Shelton came up for nominations for May election. Shelton's nomination was the only one received by the Pension Fund. His nomination was implemented by the acclamation of the Board. The term for this position is four years, expiring in July 2029.

Goodbye Leila Melendez, Welcome Back Paul Thompson!

In June, the Board extended its sincere gratitude to Leila **Melendez**, the retiring Trustee who'd served since 2017 as the Mayoral Representative to the Pension Fund. Her term ended July 1 but not without considerable previous recognition from the Texas Association of **Public Employees Retirement** Systems and the National Council of Public Employees Retirement Systems who featured her in glowing stories about female and Hispanic contributions to EPFPPF. Melendez had worked as El Paso's Chief of Staff for the City Manager from 2006 to 2013 before her appointment. She kept close watch on police and firefighter workforce dynamics and had strong influence because

of her work for Workforce Solutions Borderplex, a Texas Workforce Commission Partner.

"I will cherish my time with the Pension Fund," Melendez said. "It was a real honor to serve alongside the first responders who protect our great city. I learned so much from their insights and professionalism on the Board. The strong investment

returns achieved during my eight years on the Board are testament to their hard work."

Board Chairman **Sean Shelton** wished Melendez the best on her future endeavors.

"Leila served during a period when our pension systems' market assets grew from \$1.3

billion to about \$2 billion currently. She was a strong voice in our Boardroom and will be sorely missed."

To replace her, Mayor **Renard Johnson** appointed **Paul Thompson**, the El Paso Firefighter who retired from EPFD in February 2025 after 27 years and also resigned

from the EPFPPF after 11 years of service as a Trustee.

The Pension System requested member nominations in May. In the absence of other nominations, Jones and Nicholson were affirmed by the acclamation of the Board and will serve fouryear terms.

Got Beneficiaries? Why Updating Matters

Keeping your beneficiary information up to date ensures that your pension benefits, life insurance, deferred compensation plans (457b), and Health Savings Account reflect your current wishes. Beneficiaries must be updated separately with the appropriate providers.

Updating Prevents Delay

Your pension benefits are a significant financial asset. Being proactive with updates ensures a smooth transition for your beneficiaries and avoids unnecessary legal or administrative hurdles. Outdated beneficiary records can cause delays, legal disputes, or unintended allocations.

Only the Pension Fund Can Update Pension Beneficiaries!

Pension beneficiary designations <u>cannot</u> be updated through the City.

While active members can update their address, phone number, and marital status through the City's Peoplesoft system, changes to pension beneficiaries



must be made directly with the pension office.

The City submits member demographic updates to the Pension Fund via a bi-weekly file upload, but pension beneficiary changes are **NOT** included in those updates!

Update Types and Who Does It:

Here's how different beneficiary updates should be handled:

- **Pension** Directly with pension office.
- Last paycheck –
 Managed by City of El
 Paso Human Resources
 so members must
 update this designation
 with them.
- Life insurance beneficiary – Update through City's Benefits Services Department.
- 457b deferred compensation
 beneficiary – Managed

- by Empower, the City's vendor for 457b plans. Call 915.778.2424 or through URL above.
- HSA Call 844.729.3539 or through URL above.

Best Practices

- Review beneficiary designations regularly, especially after life events like marriage, divorce, or the birth of children.
- Ensure contact details are current so you receive important notifications about tax forms and benefit updates.
- Update beneficiaries with the correct provider, since different types of benefits require separate updates.
- Secure documentation early, such as marriage certificates or divorce records, to prevent processing delays.

Account Self-Service at the Pension Fund

All Members may access their personal pension fund information through the Self-Service Portal on the EPFPPF website. Features include:

Retired Members

- Change Address
- Update Direct Deposit (Bank account info)
- Update Federal Income Tax Election Changes
- Make or change beneficiary designations
- View pension payment information
- View prior years 1099R data

Active Members

- Run retirement estimates.
- Make or change beneficiary designations
- · View Annual Member Benefit Statement
- View Forward DROP balance if applicable

When making changes on the Self-Service portal, you will need to click on the related link in order to access and complete a DocuSign Form. The form will appear on your screen with some information pre-populated so that you only change the information you want to change. Then you can sign the document digitally (online) so that you don't have to print/sign/scan/return. Once completed, the form will be forwarded to a Benefits Specialist with the Fund.
